It enhances antifouling and new mono-component products anchoring over new gealcoat, degreased and cleaned to remove wax and other greasy substances applied for an easier detachment of fiberglass from the mould. Before applying this product, surface preparation is required.

## **Application and use**

### **SURFACE PREPARATION**

<u>Fiberglass</u>: Degrease the surface to be treated with a specific solvent or detergent. Pressure wash with fresh water and remove any trace of oil and grease. All surfaces to be painted must be clean, dry and with no contaminants. Sand down with P180 – P220 abrasive paper and apply the primer on the treated surface. Before applying Anchorguard, blow with fresh and clean air in order to remove any sanding or dirt residual.

### **CONDITIONS DURING APPLICATION**

To avoid the formation of condensation, the temperature of the surface should be at least 3°C above dew point. During application and curing, the min. ambient temperature must not be lower than 10°C or higher than 30°; substrate temperature must not be lower than 5°C. since curing is remarkably reduced at lower temperatures. Application is not advisable when relative humidity exceeds 80%. The termhygrometric survey should be carried out near the surface to be coated. Make sure there is enough ventilation when the application takes place in closed areas.

### **Storage**

It is recommended to avoid exposure to air and extreme temperatures. To maximize the shelf life in the can, it is worth checking that the container is well closed during the storage and the temperature is between 10 °C and 35 °C. Avoid exposure to direct sunlight.

### Safety rules

Observe the provisions of DPR 303 and 547. Avoid contact with the skin, for example. Operate in well ventilated places and, if in closed areas, use vacuum cleaners, fans and air conveyors. During the application use appropriate protections (masks, gloves, glasses, etc.). Before using, read sections 7-8 of the SDS.

INSTRUCTIONS FOR THE DISPOSAL OF PRODUCTS AND PACKAGING

Empty packaging that contained products: Dispose of empty packaging according to the requirements of the waste disposal law, for example by taking them to the recycling center.

Do not empty into drains or watercourses. Product packaging must be kept indoor, and the temperature in the storage place must be between 10 °C and 35 °C. Do not expose to sunlight.
